With preparations underway for the 2025 Calgary Municipal Election, The City of Calgary is answering frequently asked questions to help candidates ensure that their election signs are legally placed on public property and do not pose a safety risk to pedestrians, cyclists and motorists.

How is election sign placement on sidewalks and boulevards regulated in Calgary?

The rules for election signs are set out in the <u>Temporary Signs on Highways Bylaw 29M97</u> which regulates temporary signs placed along streets and roadways.

What is considered an election sign?

An election sign is defined as any sign used to promote a candidate or local political party during an election. Signs that do not support a candidate directly are not considered election signs and are subject to the general provisions for temporary signs in the bylaw.

What are the general guidelines for placing election signs on sidewalks and boulevards?

- Signs on a boulevard must be placed at least 2 metres back from the curb or edge of the roadway
- Election signs must be placed a minimum distance of 30 metres from an intersection and at least 10 metres from any crosswalk that is not at an intersection. Smaller election signs (less than 0.6 square metres) must be placed a minimum distance of 15 metres from an intersection
- Signs cannot be placed within 2 metres of a driveway crossing or entrance to private property
- There must be a minimum **20 metre** space or buffer between signs from the same candidate
- The date the sign was placed, as well as the name, address and phone number of the person who owns the election sign must be legibly stated on some portion of the sign

Are there any special rules for election signs?

There are some allowances that apply during the Election Period which runs from the period starting as soon as nominations close on **September 22, 2025 at noon** and ends after the polls close which will be **October 20, 2025 at 8:00pm**. These allowances include:

Distance from Intersections	15 metres	15 metres if smaller than 0.6 m2 30 metres if larger than 0.6 m2
Rules for Sign Removal	Must be removed after 14 consecutive days on display	Must be removed within 72 hours after voting stations close

Are there locations where candidates are NOT allowed to put up election signs?

Election signs are not permitted in the following locations:

- Along any Prohibited Roadway (see attached list)
- City of Calgary Parks and Pathways
- Playground zones
- On any traffic island or median

Elections signs must also not be affixed to any of the following:

- Streetlight and traffic signal poles
- Sound attenuation walls
- Plus 15 bridges
- Any Calgary Transit sign poles or structures

For complete details on where and how election signs are permitted to be placed, please see the Temporary Signs on Highways Bylaw 29M97.

How long can election signs stay up?

During the **Election Period** (**September 22 - October 20, 2025**), signs can be displayed at the same location for the entire election period, or any portion of it, but must be removed no later than **72 hours** after the polls close.

Before and during Election Period, signs that advertise a scheduled event must be removed within **24 hours** of that event concluding.

Can sign owners participants be fined if their signs do not comply with the bylaw?

Failure to comply with the regulations may result in the owner of the sign(s) receiving a penalty of up to \$1000 per sign, as well as any costs associated with damage caused by the signs and the cost of sign removal.

What happens to election signs that are removed?

Peace Officers, Bylaw Officer and City staff are authorized to immediately remove and impound election signs that are in contravention of the bylaw. Signs are held at a municipal Impound Lot and can be recovered at the owner's expense. Any election sign that impedes or interferes with the work of a City operation can also be removed and disposed of without giving notice to the owner. Please contact 3-1-1 for further information and guidance on how to retrieve impounded signs.

What are the rules for signs on private property?

Signs on private property are considered Class A signs under the Land Use Bylaw 1P2007. See Section 77 (Rules Governing Class A Signs) and Part 3, Division 5, Section 75 (Maintenance of Signs) for more details.

What laws are there to prohibit defacing election signs?

Defacing of election signs may be a criminal matter that could be investigated by the Calgary Police Service. If this type of property damage is seen, please contact the police non-emergency line at (403) 266-1234.





Election Signs

Election signs must comply with the rules for size and placement set out in the Temporary Signs on Highways Bylaw 29M97. **Infractions could be a \$300 fine.** Learn more at **calgary.ca/electionsigns**

All signs must be:


- 2 metres back from the curb or edge of the roadway,
- 2 metres from driveways or private property entrances,
- 10 metres from any crosswalk that is not at an intersection,
- 30 metres from a bus stop.


Small signs (less than 0.6 m²) must be:

• 15 metres from an intersection.

Large signs (over 0.6 m²) must be:

• 30 metres from an intersection, only used during election period.





There should be a minimum 20 metre buffer between signs from the same candidate

Signs can not be placed:

- · in parks,
- · on pathways,
- · in playground zones,
- along prohibited roadways,
- · on any traffic island or median.

Signs can **not** be attached to:

- · street light poles,
- traffic signal poles,
- · sound attenuation walls,
- Plus 15 bridges,
- any Calgary Transit sign poles or structures.



(March 21, 2025) PROHIBITED ROADS - MOBILE COMMUNITY SIGNS AND OTHER TEMPORARY SIGNS

The Mobility Business Unit places public safety as the highest priority in all its actions to sustain and enhance all forms of mobility for its customers. The Traffic Engineer has the authority to establish some of Calgary's roads as "Prohibited" from the use of temporary signs when it is deemed that signs may impact safety, sustainability or the mobility of Calgarians, no matter what form of mobility they choose.

Here is the current list of Prohibited Roads which the Traffic Engineer has banned the use of temporary signs. Please also refer to the map for additional guidance.
